1.4 Exhibitor/owner acknowledges all hazards presented by the event and the event premises, including, but not limited to, the condition of the floors, stairways, halls, lighting, security measures or lack thereof, electrical appliances, fittings, show rings, parking areas and the presence of unfamiliar animals and people; exhibitor and owner assume the risk of any harm arising from these.

1.5. Exhibitor/owner release NADAC (including NADAC officers, directors employees and members), Saguaro Scramblers Agility Club (including Saguaro Scramblers Agility Club officers, directors, and members, and event organizing committee), and the City of Tucson, AZ (including its officers, agents, and employees) and will defend them and hold them harmless from all present and future loss, injury, damage, claims, demands and liabilities involving the entered dog, the event or event premises.
