# INTRODUCING AKC ACT

## WHAT IS ACT?

AGILITY COURSE TEST (Earn an agility title on your beginner dog in a trial atmosphere) All passing scores can be under the same judge/evaluator. Only one dog in the ring at a time.

ACT1 IS AN ENTRY LEVEL TEST THAT IS DESIGNED TO INTRODUCE DOG AND HANDLER TO THE AGILITY RING AND BASIC AGILITY OBSTACLES.

ACT2 IS THE SECOND LEVEL AND DESIGNED TO FURTHER INTRODUCE THE DOG AND HANDLER TO THE AGILITY RING AND ADDITIONAL AGILITY OBSTACLES.

## WHO CAN ENTER?

ANY DOG THAT MEETS THE AGE AND PHYSICAL REQUIREMENTS FOR A REGULAR AKC AGILITY TRIAL

DOG MUST BE 15 MONTHS OLD OR OLDER

THE DOG CANNOT HAVE EARNED ANY AKC AGILITY TITLE.

NON REGISTERED (CAN BE REGISTERED DAY OF EVENT) OR AKC REGISTERED (WE WILL HAVE FORMS AT THE SHOW FOR THOSE WISHING TO REGISTER)

DOGS WITHOUT REGISTRATION NUMBERS WILL BE ISSUED A TEMPORARY ONE AFTER THE EVENT BY THE AKC OFFICE.

IF A DOG HANDLER TEAM HAS QUALIFIED AT AN EVENT WITH AN UNREGISTERED DOG THEY WILL BE SENT A QUERY TO REGISTER THE DOG AFTER THE EVENT.

**DOGS MAY BE ENTERED AT ANY OF THE FOLLOWING JUMP HEIGHT DIVISIONS AT THE HANDLER'S DISCRETION: 4, 8, 12, 16, 20, OR 24 INCHES.** THERE IS NO REGULAR OR PREFERRED DISTINCTION IN THE ACT PROGRAM. A JUMP HEIGHT CARD IS NOT REQUIRED TO ENTER AN ACT EVENT, BUT HANDLERS ARE ENCOURAGED TO HAVE THEIR DOGS MEASURED IF A VOLUNTEER MEASURING OFFICIAL IS AVAILABLE.

## TITLES

THE ACT1 AND ACT2 TITLES CAN BE ACHIEVED IN ONE DAY IF THE EVENT OFFERS 2 RUNS IN EACH CLASS

DOGS MUST BE **AKC REGISTERED TO ACHIEVE A PHYSICAL TITLE CERTIFICATE AND HAVE THE TITLE PRINTED AFTER THE DOG'S NAME**

Qualify ribbons and 1<sup>st</sup> thru 4<sup>th</sup> placement ribbons will be awarded. You MUST qualify in order to be eligible for a placement ribbon.

## PERFORMANCE - ACT1

10-12 OBSTACLES

**A-FRAME (5'), TABLE, JUMPS (NO SPREADS), OPEN TUNNELS**

COMPLETE THE ENTIRE COURSE IN 60 SECONDS WITH A SCORE OF 85, NO DROPPED BARS, NO MISSED CONTACTS, Refusal/run-outs are NOT judged. NO MORE THAN 3 ATTEMPTS TO COMPLETE ANY OBSTACLE, NO MORE THAN 3 WRONG COURSES.

## PERFORMANCE - ACT2

11-13 OBSTACLES

A-FRAME, TEETER, DOG WALK (ALLOWED), TABLE, JUMPS (SPREADS ALLOWED), OPEN TUNNELS, WEAVES (6 POLES)

COMPLETE THE ENTIRE COURSE IN 70 SECONDS WITH A SCORE OF 85, NO DROPPED BARS, NO MISSED CONTACTS, Refusal/run-outs are NOT judged. NO MORE THAN 3 ATTEMPTS TO COMPLETE ANY OBSTACLE, NO MORE THAN 3 WRONG COURSES.

NOTE: You do NOT need an ACT 1 title in order to be able to enter ACT2.

I certify that I am the actual owner of the dog, or that I am the duly authorized agent of the actual owner whose name I have entered. In consideration of the acceptance of this entry, I (we) agree to abide by the rules and regulations of The American Kennel Club in effect at the time of this event, and any additional rules and regulations published for this event and any decision made in accord with them and further agree to be bound by this Agreement. I (we) agree that the club or ACT Evaluator, holding this event has the right to refuse this entry for cause which the club or ACT Evaluator shall deem sufficient. I (we) certify and represent that the dog entered is not a hazard to persons or other dogs. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents, event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge or ACT Evaluator, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog. Additionally, I (we) hereby assume the sole responsibility for and agree to indemnify, defend and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in this event, however such, injuries, death or property damage may be caused, and whether or not the same may have been caused or may be alleged to have been caused by the negligence of the aforementioned parties or any of their employees, agents, or any other person. HOWEVER, PRIOR TO ARBITRATION ALL APPLICABLE AKC BYLAWS, RULES, REGULATIONS AND PROCEDURES MUST FIRST BE FOLLOWED AS SET FORTH IN THE AKC CHARTER AND BYLAWS, RULES, REGULATIONS, PUBLISHED POLICIES AND GUIDELINES.

**INSTRUCTIONS**

Dogs may be entered in any jump height. There is no Regular or Preferred distinction at AKC's ACT events.

In order to acquire the ACT1 or ACT2 title certificate and have the title added to a dog's record, the dog must be registered/listed with the American Kennel Club. **AKC Canine Partners<sup>SM</sup>** applications may be accepted at the event and submitted to AKC with the event's results.

Dogs that are not AKC registered/listed may be registered at a later date and receive their ACT title at that time.

Dogs listed in the **AKC Canine Partners<sup>SM</sup>** program should be listed as All American Dog and must include their AKC number on the entry form and check the AKC No. box.

**Junior Handlers** should enter their Junior Handler Number on the front of this form. Should you not have your Junior Handler number, it may be obtained from the American Kennel Club (919) 233-9767. If the Junior Handler is not the owner of the dog identified on the face of this form, what is the relationship of the Junior Handler to the Owner?
