Saguaro Scramblers COVID-19 Rules, Recommendations and Waiver (You must sign and return with trial entry)

COVID-19 Rules

Saguaro Scramblers USDAA COVID-19 rules have been developed to maintain compliance with current Kino Sports Complex requirements (a Pima County Facility) as well as current CDC recommendations.

Kino Sports Complex limits gatherings to a total of 50 people per day. Non-volunteering non-competing guests and spectators are not allowed at this trial with the exception that a guest may come briefly in the morning to help set up your canopy and pack up at the end of the trial. Volunteering non-competing guests are allowed if they volunteer at least 3 classes per day and must be declared in advance on this form or by emailing the trial secretary and will be included in the 50-person limit.

FACE COVERING/MASKS covering both the mouth and nose are required to be worn when an individual cannot maintain a continuous distance of 6' from other individuals. However, individuals traveling together are exempted from this rule when near only each other.

Specifically, face coverings are required during walk-thrus, briefings, during volunteering if continuous social distancing is not possible, in restrooms, near score/secretary tables, and while in designated high traffic area in front of rings. Masks must be worn when approaching another competitor, trial committee, volunteers, or judge unless properly socially distancing.

Face coverings are not required while running your dog in the ring, in your canopy, or while walking around (other than in the marked high traffic area in front of the ring entrances) provided you maintain social distancing.

Disposable masks will be available at the trial for anyone who needs one. Masks are the preferred face covering, but gaiters and bandanas are also acceptable as long as they cover both the mouth and nose.

CANOPIES: Canopies and tents are to be set up with 8' of space in between them. (As stated above, individuals traveling together do not need to wear a mask when together, so a mask is not required while utilizing canopies/tents, unless entering the tent of someone not in your party.)

RULES FOR WORKERS: If volunteering in a job where you cannot maintain at least 6' of continuous social distancing, you are required to wear a mask.

LEASH RUNNING: Leash runners will use a sanitized "grabber" to pick up and carry leashes and wear a mask unless they can continuously maintain a distance of 6' from other people.

Failure to comply will initially result in a reminder of the rules. **Deliberate refusal to comply** with these COVID-19 rules will result in expulsion from the trial and that individual must leave the facility immediately with no refund given.

COVID-19 Safety Recommendations and Precautions

- Hospitality will not be provided at this trial, other than water bottles. Please bring your own food and refreshments.
- Please be aware of items that you touch that may have been touched or will be touched by others (e.g., either wear gloves or sanitize hands immediately before and after if you are touching things that are touched by others)

- Avoid touching your face.
- Wash your hands often with soap and water and/or use hand sanitizers (gels, wipes, etc.); please bring your own to assure availability.
- Restrooms are single occupancy and hand sanitizer and soap will be provided.

Waiver

If you are concerned about the possibility of exposure to the coronavirus OR if you are unwilling to follow the stated rules, it would be best if you did not enter this October trial.

I agree that if I am diagnosed with COVID-19 within 14 days of the first day of the trial, I will not attend, and can contact the trial secretary for a refund.

I agree to not attend the trial if I am exhibiting COVID-19 symptoms, including but not limited to cough, sore throat, fever, and shortness of breath, or have been knowingly exposed to COVID-19 within 14 days of the trial.

I agree that I am attending the Saguaro Scramblers' USDAA agility trial on Oct 16-18 entirely at my own risk and take full responsibility for my own health and safety during this event.

I agree to follow all event and Kino Sports Stadium requirements, procedures, protocols and guidelines to reduce any exposure and possibility of contracting or spreading the virus. If I deliberately refuse to follow the rules as stated above, I understand that I will be asked to leave and will not be refunded entry fees.

I agree to follow CDC, Federal, State of Arizona, Pima County, City of Tucson guidelines in regard to COVID-19. I fully submit that the USDAA, Saguaro Scramblers, Kino Sports Complex, and all other contracted staff & employees, any workers or volunteers, are in no way liable for any present or future COVID-19 exposure incurred at any time by any person, in attendance or not in attendance, during or after this event, and hereby waive all rights to file a lawsuit against above if I am exposed to COVID-19.
